# Introduction

The **Royal Commission** into **Violence**, **Abuse**, **Neglect** and **Exploitation** of People with Disability is looking at people with disability in Australia and their

- Safety
- Treatment
- Rights, and
- Supports

We call it the Royal Commission.

We want to know about the experiences of people with disability in the **criminal** justice system.

The criminal justice system deals with **criminal offences**. This is also called breaking the law.

#### It includes

- Police and detectives
- Lawyers including Legal Aid
- Courts including judges
- Victim support groups and services
- Community corrections officers
- Prisons and corrections officers

# Issue

People with disability are more likely to be involved with the criminal justice system.

# This might be because

- You are more likely to be a victim,
- You may have broken the law or be a witness to a crime
- You do not understand the law and your rights
- You have difficulty speaking up for yourself or being listened to

- You do not or cannot ask for help
- You have a behaviour because of your disability that other people do not like.

You might also have other high risks like

- You are homeless or poor
- You are First Nations
- You are from another country
- You do not speak English

There are also less disability supports in the criminal justice system so you are at higher risk when you are in the system.

- 1. Tell us about experiences with the criminal justice system
  - For you
  - For other people you know.
- 2. Violence, abuse, neglect and exploitation happen a lot to people with disability in the criminal justice system. Tell us
  - Why you think this happens

• What changes could make it safer

#### 3. Tell us

- what you think would protect people with disability in the criminal justice system
- about problems you've had staying safe
- 4. Many people with disability need support to deal with the criminal justice system. Tell us
  - What supports would make them equal with people with no disability
  - When they need supports if they are
    - o A victim
    - o A witness giving evidence
    - Accused of a crime
    - o Found guilty of a crime
    - o On a jury
  - What would be good supports
- 5. Tell us how violence, abuse, neglect and exploitation change for different groups of people. This might include
  - Their gender or sexual identity
  - Their age
  - Their culture

- Where they live
- 6. Tell us about the experiences of violence, abuse, neglect and exploitation for First Nations people in the criminal justice system.

## This might include

- Services appropriate for their culture
- The supports young First Nations people need
- What would help First Nations people to move out of the criminal justice system
- 7. Many people with disability find it hard to tell someone and get help to deal with violence, abuse, neglect and exploitation in the criminal justice system.
  - What stops people from speaking up
  - What needs to change to make it easier for people to ask for help
- 8. Violence, abuse, neglect and exploitation against people with disability in the criminal justice system is not always **investigated**.

# **Word List**

#### **Abuse**

If someone is treating you badly.

## **Advocacy**

When someone speaks up for themselves or someone who cannot speak out

#### **Bold**

Dark writing like **this** is bold.

#### **Corrections Officer**

The people who are paid to take care of the safety and behaviour of people who break the law.

This might be in prison or in the community.

# **Criminal Justice System**

All things that deal with someone breaking the law.

This includes police and courts. It also includes prisons and victim support groups.

## **Criminal offence**

This is also called breaking the law.

## Culture

Culture is the way we live.

It comes from our family and society. It can include language and food.

## **Emotional**

To do with the way you feel.

# **Exploitation**

If someone is taking advantage of you.

## **First Nations**

Name used for Aboriginal and Torres Strait Islander people.

#### Gender

Whether people are male or female, non-binary or another gender.

# **Investigated**

When someone looks for the facts about a problem and deals with it.

## Jury

People from the public who listen to evidence and decide if someone is guilty.

## Legal

To do with the law.

## **LGBTQI**

Stands for lesbian gay bisexual transgender intersex and queer or questioning.

# **Neglect**

If someone is not helping you the way they are supposed to help you.

#### **Risks**

These are things that make you more likely to be hurt or treated badly.

# **Royal Commission**

A formal public inquiry.

It is an official way of looking into a big problem and working out what went wrong.

# **Sexual Identity**

The type of people someone is sexually attracted to.

There are many types including heterosexuality and homosexuality.

## **Victim**

A victim is someone who has something bad happen to them.

This can include violence or abuse.

## Violence

If someone is hurting your body.
